



The residence at Mount Carmel, the Branch Davidian community east of Waco,

Texas, prior to the 1993 assaults by federal agents.






• The second level of the Mount Carmel, comprised of the women's bedrooms. •






On February 28, 1993, agents with the Bureau of Alcohol, Tobacco, and Firearms carried out an armed raid on Mount Carmel with the intention of delivering warrants, during which a shootout occurred. Four ATF agents were killed.





Bullet holes pierced the doors and the second-floor walls and windows of the front of the building.




Perry Jones (64, American) received a mortal wound from a bullet that penetrated the front door.

Jaydean Wendel (34, American) mother of four



Michael Schroeder (29, American) was shot and killed as he tried to walk back to Mount Carmel. The circumstances of his death were never fully investigated.




Map of Mount Carmel and surrounding area, showing the location behind the Mount Carmel property where Michael Schroeder was killed by ATF agents.







FBI agents assumed control of Mount Carmel on March 1, 1993 to oversee the siege.


Tanks were brought onto the property the following day. The tactical aspects of the siege were carried out by the Hostage Rescue Team.












The Branch Davidians made videotapes during the siege, which featured statements revealing that the adults chose to remain inside the building. The following images are taken from the video.

The FBI's Hostage Rescue Team began a tank and CS-gas assault on the residence on the morning of April 19, 1993. The tanks (Combat Engineering Vehicles) demolished parts of the building. Here a tank enters the front door to gas the vault at the base of the tower.





After a tank inserted gas into the second-floor southeast corner front window, the first fire was visible at 12:09 Central Time. The FLIR image below shows fire in several areas of the building.



After the fire, only the concrete vault, water tower, and a cement-block structure next to the water tower remained standing. Twenty-two children ages 13 and younger and their mothers died in and near the vault. Two newborn infants died after their pregnant mothers gave birth during the assault and fire.







The Branch Davidian flag burned in the fire. After the fire died down, an ATF flag was raised over the remains of the building.

In 1995 crape myrtle trees were planted at Mount Carmel for each Branch Davidian who died in 1993. A new chapel was completed in 2000.



A memorial stone for each deceased Branch Davidian was placed beneath a tree.





After Clive Doyle moved away from Mount Carmel in 2006, a rival claimant to the property uprooted and moved the crape myrtle trees. David Koresh's tree and memorial stone were destroyed.



The memorial stones for the deceased Branch Davidians have been cemented together in a display near the front gate.



After rubble was moved out of the cement swimming pool in 2011, researcher Matthew D. Wittmer discovered an inscription made by David Koresh on the bottom step: "DK '92 BOOM." A Star of David is drawn below "DK." 1992 is when the pool was constructed.

A memorial service was held on April 19, 2013, the twentieth anniversary of the fire, at the Helen Marie Taylor Museum of the Life and History of Waco.
